1. Chairman's Welcome and introduction of speaker

M Cater welcomed everyone to the meeting and wished everyone a Happy New Year. The guest speaker was introduced as Sarah Brooke-Taylor who is the Neighbourhood Development Officer for Warwickshire Rural Community Council (WRCC) and will be giving a short presentation about Parish Plans.

2. Apologies Councillor G Roache (SDC)

3. Presentation

Sarah explained that the WRCC was a charity involved in many countryside issues and can offer help and advice. Parish Plans (PPs) are community-led in that communities work together on issues such as Footpaths, Transport, Housing Needs, Communications, Environmental Issues, the Elderly and any other matters pertaining to that particular community. and form a plan on the best way to solve any problems identified. Parish Plans, although not a legal document, do carry some weight with local authorities. There are 4 stages to forming the plan. 1. Research which will involve Public Meetings and circulating questionnaires. 2. Major Issues are identified when the data has been collated from the survey. 3. Analysis and Reports are produced and an Action Plan put together. 4. The findings are then presented to the Parish Council and this is used as a working document for the community.

Sarah explained the difference between a Parish Plan and a Neighbourhood Plan (NP). A NP is a legal document and deals mainly with development issues and also costs considerably more to produce. There is some cost in producing a PP but grants may be available. Help and advice are available from WRCC and also SDC and information can be found on the websites.

Sarah answered a few questions from those present and distributed leaflets. M Cater thanked her for clarifying what Parish Plans involved.

9. Any Other Business

- Complaints re continuous barking of a dog Kiblers Lane area. PC suggested neighbours have a friendly word with the owner.
- The PC was informed that Sat Navs are directing people travelling from certain areas along the Walton Lane, across Kineton Rd and along Kiblers Lane to reach the A422 to Banbury. Traffic is travelling at speed along these single track roads and causing residents problems. The PC will speak to the Police about this at the next Community Forum and also ask WCC if any signage would help.
- It was reported that a chimney flue obviously now in use as smoke is visible is seen at Shabby Shack on Banbury Rd. The question was asked if Planning consent is needed for this addition. Clerk will ask SDC planning dept.
- R Thompson on behalf of the Village Hall and parishioners wished to express thanks to the Parish Council for helping to bring a successful result in the recent Planning Appeal. M Cater thanked Mr Thompson but added that the support of parishioners had been invaluable at the Appeal. It was very much a community effort.
- M Fox said that during recent heavy rainfall the drain outside Sunset on Kineton Rd was again gushing out water which then flooded along Kineton Rd towards Pillerton Hersey. The Clerk will report to WCC.
- M Fox said that a quantity of household rubbish had been dumped in Walton lane. Clerk will notify Street Scene and ask them to remove it.
