Annual return for the year ended 31 March 2017

Every smaller authority in England with an annual turnover of £6.5 million or less must complete an annual return at the end of each financial year in accordance with proper practices summarising its activities. In this annual return the term 'smaller authority'* includes a Parish Meeting, a Parish Council, a Town Council and an Internal Drainage Board.

The annual return on pages 2 to 4 is made up of three sections:

- Sections 1 and 2 are completed by the smaller authority. **Smaller authorities must approve Section 1 before Section 2.**
- Section 3 is completed by the external auditor.

In addition, the **internal audit report** is completed by the smaller authority's internal audit provider.

Each smaller authority must approve Section 1 and Section 2 in order and in accordance with the requirements of the Accounts and Audit Regulations 2015.

Completing your annual return

Guidance notes, including a completion checklist, are provided on page 6 and at relevant points in the annual return.

Complete all highlighted sections. Do not leave any highlighted box blank. Incomplete or incorrect returns require additional external auditor work and may incur additional costs.

Send the annual return, together with the bank reconciliation as at 31 March 2017, an explanation of any significant year on year variances in the accounting statements, **your notification of the commencement date of the period for the exercise of public rights** and any additional information requested, to your external auditor by the due date.

Your external auditor will ask for any additional documents needed for their work. Unless requested, do not send any original financial records to the external auditor.

Once the external auditor has completed their work, certified annual returns will be returned to the smaller authority for publication and public display of Sections 1, 2 and 3. You must publish and display the annual return, including the external auditor's report, by 30 September 2017.

It should not be necessary for you to contact the external auditor for guidance.

Matters reported

Clerk and Chair are related

We note that the Clerk and the Chair are married.

The Clerk to a local council is the 'Proper Officer' appointed under the Local Government Act 1972. The person appointed has a statutory duty to carry out all the functions of the council, including to advise councillors, produce all the information required for making effective decisions and implement decisions. He/she is accountable to the Council for the effective management of all its resources and may also be the 'Responsible Financial Officer', as required by Section 151 of the Act, responsible for all financial records of the Council and the careful administration of its finances. Councillors are responsible for governance, including determining Council policy and monitoring and reviewing performance in delivering services and managing resources. In order to maintain the governance role separately from the management role and to remove any perception of conflict of interest, councillors, and in particular the chair should not be related to either the 'Proper Officer' (the clerk) or the 'Responsible Financial Officer'. Where this happens the Council should carry out a full risk assessment, consider actions to mitigate the risks, minute this and seek to fill the post as soon as possible. In our view, the correct answer to Section 1, Assertion 1 is 'No'.

Further guidance on the role of officers and councillors can be found in 'Governance and Accountability for Local Councils – A Practitioners Guide (England)' and at Regulation 4 of the Accounts and Audit Regulations 2015.

Internal Auditor's Report
